Thank you for your intended gift of securities to your chosen United Methodist church, ministry or organization. The Foundation is a service agency incorporated to help the churches of the Conference with such gifts. These gifts could include stocks, bonds, or other investments.

The Foundation has a brokerage account already established which eliminates the need for churches of the Conference to have such accounts. We receive up to a 25% discount on the broker's fees. The Foundation exists to serve and does not benefit from these transactions.

All net proceeds from the sale of the securities are directed to the donor's intended United Methodist church, agency or mission.

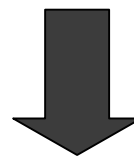
