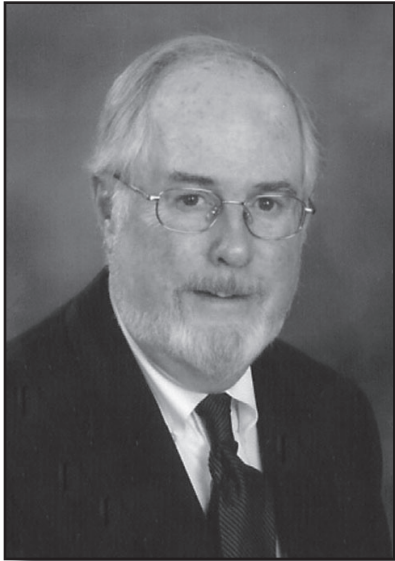

# Methodists Helping Methodists Fund *Report*

The Methodists Helping Methodists Fund (MHM Fund) exhibited strong core growth in 2006. Investor deposits increased from \$3.2 million to \$3.6 million. Forty-four new accounts were added in 2006, for a total of 220 accounts held by 128 investors. Investors come in all ages and types, from grandchildren to seniors, from trusts held by agencies to churches. They like seeing their short-term investments supporting the connectional system.

The Fund originated seven new church loans totaling \$511,721 in 2006: new windows at Mountain View UMC, Boulder; day care center improvements at Fruita UMC; new roof at DeBeque Community UMC; new boiler at Wheat Ridge UMC; new sound booth at First Grand Junction UMC; refinanced parsonage loan at Korean American UMC, Colorado Springs and new windows at First UMC, Glenwood Springs.

These are great 2006 numbers. As a retired banker, I am proud of this performance. As an active Methodist, a MHM Fund investor,

and Chair of the MHM Fund it's about much more than the numbers.

There is the support of the local United Methodist mission throughout the RMC. There is the competitive return we provide our investors and the great service they receive from the Foundation. There are loyal investors who make the decision every year to include the MHM Fund in their investment choices. There are churches large and small being helped with loans to better serve their communities. And there is great joy in knowing the MHM Fund loan is often at a better rate and term than available elsewhere for churches.

Please consider increasing the diversity of your portfolio with an investment in the MHM Fund. You'll see the return is much greater than the interest rate. We don't give airline mileage or giveaways but the Fund is making a difference in the life of United Methodist Churches. We just share Methodist love with Methodist money through the MHM Fund.

# Planned Giving Services *Report*

We are pleased to announce during 2006 the Foundation contracted the services of Linda L. Gardner, CPA, Gift Planning Director, and Carl Gardner, Financial Education Director in 2006. They will be traveling around the Conference to provide assistance in setting up endowment programs for churches, as well as, educational workshops on planned giving and estate planning.

They will also provide confidential no-cost consultations with prospective donors. Our hope is to serve you and your family with helpful information. We have an increasing number of friends who now are benefiting from life income gifts such as charitable gift annuities.

Two gift annuities were completed in 2006. Charitable gift annuities provide partially tax-free income for life to donors and a charitable deduction on their income tax. Donors may also avoid capital gain tax if the gift is funded with marketable securities. Secondly, at the passing of the donor, 80% of the remainder is returned to their designated United Methodist Church or UM agency.

Ray Allison of Longmont shares his story at the right. We are privileged to partner with the Allisons and many others in the Lord's work to build church permanent endowment funds through these types of planned gifts.

## Meet our newest charitable gift annuitants

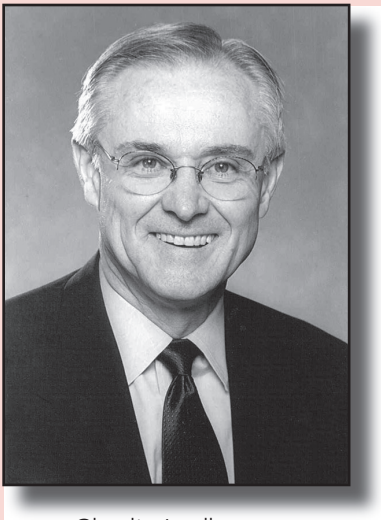
While I have been aware of Charitable Gift annuities for many years, it was an article published by the United Methodist Foundation recently that helped me realize that this was an instrument which could satisfy several of my desires at one time.

My wife and I owned a large number of shares of my former employer's stock, which had appreciated significantly in value over the years. I wanted to reduce our holding in that one company to improve the diversification of our portfolio, but I didn't want to pay the large capital gain tax that would be due if I sold it. In addition, the stock was paying only about 1% per year in dividends and I wanted a higher income to supplement our retirement.

I already had a feature in my will to provide a donation to our local church upon my death. So, I thought, why not arrange for that donation now, via a Charitable Gift annuity. That way we get a tax deduction now, a higher income for life (part of which is tax exempt), and my church will receive a substantial donation when I die. Now, that's a Win-Win-Win situation, if I ever saw one!

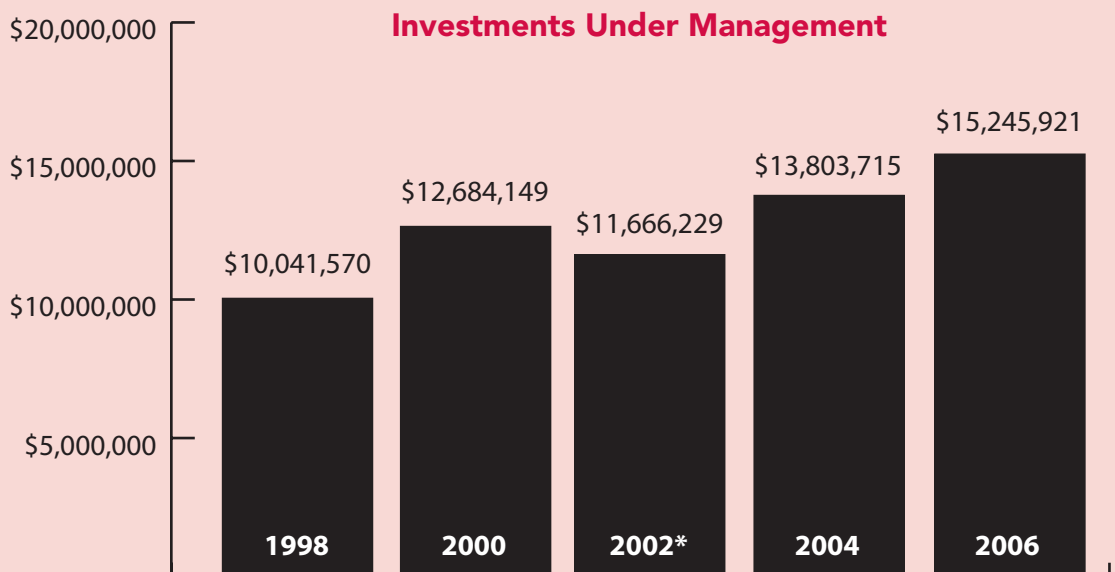

## INVESTMENT FUNDS

The Foundation offers investment funds to churches within the Rocky Mountain Conference. These funds reflect the socially responsible investment policies set out in the Social Principles of the United Methodist Church. The screening for social principles is combined with the Foundation's policy of seeking long-term growth for equity investments and income with preservation of principal for income oriented investments.

Many churches find investing through the Foundation as an easy and convenient way to meet their needs. The Foundation offers

specialized experience and the avoidance of any conflicts of interest. Sub-account reporting allows smaller investments by the churches than might be commercially unavailable. We believe the local church and the Foundation together are stronger than either would be standing alone. This also allows the Foundation to keep its costs and expenses competitive. All of these factors have allowed the Foundation's investment portfolios to serve more and more churches for almost two decades. Below is an historical graph of the continued growth of investments under management.

## EQUITY GROWTH FUND

The Foundation has offered this type of investment Fund since 1993. The total return numbers for the Foundation EQUITY GROWTH FUND are compared with the U.S. equity investments as measured by the S&P 500 composite index and the broader market measured by the Russell 2000 growth index. Please note that the Foundation's return is net of fees and expenses while index returns do not have such fees and expenses. Also, Foundation Funds meet social principles of the UM Church while indexes do not. Total assets under management in this Foundation Equity Fund at year's end were \$4,670,801.

## FIXED INCOME FUND

This Foundation Fund has been in existence since 1987 and is designed to meet the income needs of many churches. The Federal Reserve continued to raise short-term interest rates during the first half of the year and then held rates stable for the remainder. **This led to the downturn in the value of Bond Funds.** The Foundation Fund is compared below to the Lehman Aggregate Bond Index. Total assets under management in this fund at year's end were \$8,898,113.

## MONEY MARKET FUND

The Money Market Fund offered a 2006 average return of 3.52%. This improved some from previous years and reflected the rise in short-term interest rates during the year. The total assets under management in this fund at year end totaled \$ 1,629,428.

New investments and additions to all three Funds totaled \$1,584,155 for 2006. Withdrawals of \$931,109 were processed to meet the needs of churches. Also accounts in the Fixed and Money Market funds earned over \$521,959 in interest income.
